It was suggested training be conducted on the system if there was interest with the matter to be placed on the PST meeting agenda with Jeremy Cook to provide a presentation.

# Safety Work at Durack

General Manager advised safety work was underway.

# Canine Welfare Officer

Directors noted the information provided. The Chair commented the proactive role should involve liaison, education, assistance and support for breeders and members in a collaborative way. The role should also raise the profile of Dogs Queensland.

Discussion followed on whether the role was a full-time position, the need for a budget to be put in place to cover salary and benefits, for example travel costs across Queensland with an expectation the role would cost around \$100k per year. It was suggested the position description be finalised and considered at the February 2023 Board meeting.

Noted with the Chair suggesting a Board meeting should be held at Caboolture at a date to be decided to view the facilities.

# Cyber Risk, Data Security & Privacy

General Manager advised two-factor authentication and a password policy had been implemented with work continuing on IT matters. The implementation of a Risk Management Plan was critical and should be updated and reviewed regularly by the Board. The changeover of Committees would occur following the March 2023 AGM and consideration should be given to introducing an Audit and Risk Management Committee.

Directors discussed the quotes provided noting the plumbing and electrical work was required to be completed at a cost of  $^{\sim}$ \$60,000. It was proposed to complete these two stages before progressing any concreting work.

The tagging of power equipment and monitoring was important noting an appliance belonging to a business such as Dogs Queensland needed to be tested and tagged. General Manager was requested to contact the insurers to ensure Dogs Queensland was covered should powered sites be hired out. A policy document would be required on site allocations which was likely to be 'first in, best dressed.' GM noted a residual current device (RSD) should be in place.

# **Durack Grounds Committee**

# **Grounds Committee meeting Minutes from 11.01.2023**

Directors noted the information provided with the following matters highlighted and discussed:

One light protype installed for testing.

- Tree removal and replacement of the fence with the General Manager advising quotes had been obtained. It was proposed to install a chain wire fence which was around \$60K with Council approval to be sought on the removal of trees.

### **QDS PST Minutes**

Directors noted the information provided, including:

- ANKC Ltd meeting agenda with Dogs Sports asking for full membership of FCI.
- Requests for hard copies of Dog World which the Office could print. It was costly to provide a hard copy magazine which was why the magazine was moved to online resulting in a \$50K saving.

### Proposal re SprintDog Run

Directors noted the information provided with considerable interest in the sport and the need to identify an area if ANKC Ltd approval was received. Risk factors had been flagged with recommendations made the catcher was to be a person known to the dog and mentoring and training to be implemented for Lure drivers.

Directors endorsed the recommendation that should the sport be approved for a working party, a dedicated track with a sandpit be installed at Durack, noting there would be no cost to Dogs Queensland.

### SprintDog – Expansion of Rules

Directors noted the information provided, with the matter progressing.

### Recommendation from the Lure Coursing Subcommittee to be endorsed by the DQ Board

Directors noted the information provided. Directors endorsed the recommendation for all judges to complete a lure driver course.

### Canine Health Committee – Vet training for RFGS for Brachycephalic Breeds

EMC provided a verbal report noting the proposal to conduct vet training in Queensland with the Professor to travel from Victoria. Directors agreed EMC contact the Professor to pursue discussions on conducting Vet training in Queensland. It was noted a CPD program would enable points to be obtained and legitimate training was tax deductible.

# **Updated Model Rules of Association**

Directors noted the information provided with GM advising the Cairns Club AGM was scheduled to be held on 28 January 2023. Should the updated model rules of Association be adopted by the Club and accepted by the Office of Fair Trading, the rule would be used as the model for all other clubs in Queensland.

The Constitution & Rules Committee would discuss two issues, namely:

- 1. A grievance procedure with the Model Rules requiring clubs to have a policy in place.
- Legal representation permitted at hearings noting this did not occur until the Appeals stage in the rules of Dogs Queensland. The inconsistency between the Model Rules and Dogs Queensland Rules would need to be addressed.

Directors discussed the information provided and agreed to the request from the Callide Valley Canine Club. It was noted the cut-off date for 2024 Show Dates needed to be observed with the matter placed on the PST Agenda.
