

CASUAL EXHIBITOR POWERED SITE GUIDELINES

The benefits of the Casual Exhibitor Powered Site agreement goes hand in hand with responsibilities for Dogs Queensland (DQ) members on the grounds and for the Affiliated Clubs concurrently holding events at Durack.

These Guidelines have been drafted to provide information about the Casual Exhibitor Site (Powered) agreement linked to events held at Dogs Queensland Sports Ground (Durack).



1. Exhibitor Powered Sites have been installed for twelve (12) sites as highlighted in the aerial picture above.
2. The site fee is \$30.00 plus GST per site per day. Bookings can be made up to twenty-four (24) hours prior to the gazetted start time for the event and can only be made online using the Dogs Queensland Online Booking. A permit will be issued once the online booking is complete and this must be clearly displayed at all times when you are onsite.
3. Each allocated site allows for a one (1) vehicle with one (1) trailer / float or one (1) motorhome with one (1) trailer / float. Sites 2 and 10 are for Gazebos Only.
4. Sites and Utilities cannot be shared. Overnight camping is strictly forbidden.
5. Sites are occupied at the user's own risk.

6. Please refer to the diagram on the last page of this document that shows the twelve (12) Exhibitor Powered sites available and their locations. Any activities or arrangements which do not comply with permit requirements are likely to result in compliance notices/fines and may result in cancellation of the existing permit.
7. Members who choose to camp in any form are breaching the permit and undertake this activity at their own risk and are liable to disciplinary action.
8. Members should be aware that failure to comply with the legal requirements under the BCC camping permit could adversely affect their coverage under the DQ insurance policies.
9. Exhibitor Powered Site hire is only permitted when it happens in conjunction with events being conducted by the host Affiliated Club(s).
10. Set up will be permitted from 4:00pm on the day prior to the start of the event until the event concludes.
11. If there are continuous events at Durack for more than one day, Exhibitor Powered Site hire will be permitted from 4:00pm on the day prior to the first event commencing until the last event concludes.
12. Exhibitor Powered Sites are not allocated to any particular person and are allocated on a 'first come first served' basis but no bookings will be taken any further than seven (7) days prior to the event.
13. Exhibitor Powered Sites are to be left clean and tidy and it is the responsibility of the hirer.
14. It is the responsibility of Clubs hosting events to advertise and be responsible for ensuring these Casual Exhibitor Powered Site Guidelines are adhered to.
15. Power is to be used only within the boundary of the Casual Exhibitor Powered Site.
16. In wet weather, all electrical leads are to be covered by wet weather housing
17. Any exhibitors intending to bring electrical equipment to the Durack Showgrounds will be required to ensure that such equipment is fitted with residual current protection and that all electrical leads, tools and appliances have been inspected by a licensed electrical contractor and currently tagged. The use of double adaptors is prohibited, and all power boards must also be tested and tagged.
18. Accidents or damage to property must be reported to the Events Manager or Grounds Manager and the appropriate Incident Report Form is to be completed;
19. Durack Safety Guidelines are to be adhered to at all times;
20. Keep all valuables safe, they are your responsibility.
21. Ensure that you familiarise yourself and adhere to these Casual Exhibitor Powered Site Guidelines, AS/NZS 3001:2008 Provision of Connection Instructions for Caravan Parks Patrons, and the Durack Evacuation Plan.
