## Paws Aid ANZAC Day Show – P and L

Directors noted the information provided with the General Manager advising the donation had been sent to Dogs NZ.

Discussion followed on fundraising shows noting there were business operating costs for Dogs Queensland such as use of the grounds, lighting etc. It was suggested funds raised should be applied to bettering the grounds. Various committees undertook considerable work in conducting shows with a query raised on whether there was any reward or benefit for Committees which raised the most funds.

# Director Expenses Claims

Directors discussed the matter of Director Expenses claims noting there was no documented policy. Travel was usually booked through the office and one night's accommodation provided. It was a matter for the individual Director to claim for expenses, for example petrol costs. GM commented the new Associated Incorporation Act required any remuneration paid to Directors to be declared.

Directors requested the General Manager prepare a Director Expenses Claim policy for consideration at the next Board meeting.

## SHOW MATTERS, SHOW/TRIAL DATES AND CLUB MATTERS

## **Show Dates**

Directors discussed the information provided and approved the requests for:

Directors were unable to approve the dates requested by the Qld Gundog Association due to other shows scheduled at that time. General Manager was requested to write to the Qld Gundog Club suggesting the two shows be scheduled for one day, either the Friday or the Monday.

Discussion followed on the Junior Handler Committee request and whether a Junior Kennel Club existed as no financials or annual reports had been provided. It was suggested the Junior Kennel Club should operate wholly under the Junior Handler Committee with a combined show held and a fresh Charter established. Financials and annual reports would be required and the details on and number of members. The consensus of Directors was there was a need to promote the involvement of younger people in the Dog World and for junior handlers/members to run shows and hold executive positions to gain experience, not adults or family members. Duncan McAllister offered to act in a mentoring role.

Directors agreed a show date for the Junior Handler Committee of 12/13 October 2023 noting the last weekend of October was usually reserved for the Dog of the Year show.

# Correspondence re API

Directors discussed noting from the Club's perspective the increased Ground Levy charged by Dogs Queensland had been imposed without consultation. There was a 50/50 partnership arrangement however most of the organisation for shows was undertaken by the Club with limited work by Dogs Queensland office staff. It was noted office staff were employees and were required to be paid for work undertaken whereas Clubs utilised volunteers. Directors were appointed to the Board to represent and protect the interests of Dogs Queensland as a whole, not individual Clubs or personal interests for a Club.

A possible resolution and options were considered noting the need for consistency on decisions made. The API situation differed to office staff working for Clubs and members and the value of food provided and sponsorships were not a cost to the Clubs. There was considerable work involved in the promotion of the JV arrangement and the difference between a levy of \$5.25 and \$5 amounted to \$1,000. The main issue of contention was insufficient notice to the Club on the 25 cent increase.

Directors resolved the 25 cents Ground Levy not be imposed for all Clubs for 2023 with the matter to be reviewed for the 2024 year. In 2024 the holding of shows by Dogs Queensland in conjunction with Clubs would be renegotiated.

# German Shepherd Dog Club – Application for 2025 National Show

Directors noted the information provided with the issue of the use of guns/starting pistols on the grounds to be investigated further, for example insurance, before replying to the German Shepherd Dog Club.

Discussion followed on the membership applications with 178 new applications for membership received since the last Board meeting on 18 April 2023 approved.
