## **SPRINTDOG™ TRIAL MANAGER'S REPORT – Part B**

### **TRACK DESIGN AND DOG SAFETY**

*The accountabilities set out below have been established to ensure track design used in this event allows for the safest and fairest conditions for all competitors and dogs taking part and follows the rules of Dogs Australia.*

- ❖ The Sprint Zone is the area that contains the Start Box, Sprint Area and Catching Pen
  - ❖ The Sprint Zone must be the following lengths:
    - Start Box Length - 4 metres
    - Start Box Width - 3 - 10 metres
    - Sprint Area Length - 100 metres
    - Sprint Area Width - 3 - 10 metres
    - Catching Pen Length - minimum 30 metres (if return to handler course is being used the pulley must be placed 50 metres pass the finish line)
    - Catch Pen Width - no smaller than Sprint Area Width
    - No Go Zone - minimum 10 metres
  - ❖ The lure line must be securely anchored to the ground to minimise the risk of dogs becoming entangled by the line with the exception of a Drag Lure Setup.
  - ❖ The Lure may contain a squawker. In the case of a Drag Lure Machine. The Lure must be of artificial nature and be suited to the machine. In the case of a Continuous Loop System, the Lure must be odourless plastic or fabric of high contrast to the surrounding environment. A maximum of two Lures may be used. They must be of the same type.
  - ❖ The Sprint Zone is a 'NO GO ZONE' to all competitors and spectators other than those competing at the time. \*
- \* The only exceptions to the 'NO GO ZONE' are made with the permission of the Trial Manager and only made in conjunction with the Judge and Competitors – e.g. Photographer, Trainee Judge, etc. These conditions are set out as minimum requirements and were developed by the Dogs Queensland SprintDog Sub-Committee and will be the accountability of the Event Manager to ensure compliance.

- ❖ The Sprint Zone was set up to the standards described above.
- ❖ Rules and Regulations of SprintDog™ followed at this event.
