required, otherwise matters would be taken on notice and not discussed. Recovery of monies for the unfinished grounds work by the contractor and claim to be lodged with QCAT was noted, with Tim Thomas and Belinda

Thomas offering to assist with the claim. Updates on any claim made would be provided to the Board.

GM commented on the Corporations Act noting the protections provided to a Board for reasonable and

responsible actions and decisions made rationally and in best interests of the company at the time. Two relevant

areas of the Corporations Act included:

a) Duty of care and diligence, with Directors making decisions to the best of their ability with the information

in front of them; and

b) The business judgment rule for a decision made in good faith and for a proper purpose.

# Update on renovation of Rings 1-10

General Manager advised all concrete pads under the shelters should be completed by 24 April 2024 in time for the agility trial on Friday, 27 April 2024. Discussion followed on the encroachment of the pads on the agility area noting the area provided should be adequate for the trial. The Chair commented she would discuss the issues with the dog agility group noting they should have approached Dogs Queensland on the matter.

Directors queried the amount of bindi in certain areas noting spraying and then mowing resulted in the spread of burr weeds. General Manager was requested to check the area at the back of ring 16 for bindi. A further quote was to be received to finish all of the work to move the stockpiled roadbase on the grounds. However, the General Manager advised he was unaware of any comments or opinions by grounds staff to the effect the work had not been completed properly.

# Quote broken pipe leading from Campers' Toilets

General Manager advised an insurance claim had been lodged noting Urban Utilities claimed the sewer out and rising main belonged to Dogs Queensland, which required clarification. The clogging of the pipe was due to the wrong materials being placed in the pipe, with the General Manager advising he had met with the plumber. The repair work was required as soon as possible and would be expensive.

The upcoming events for the next two weekends were noted, with the General Manager advising a bank of Portaloos had been organised. The showers would remain open, however the toilets would be locked.

Directors agreed the General Manager action the hiring of the Portaloos and fixing the broken pipe.

### LED Lights for grounds

General Manager advised LED lights for the grounds were being investigated.

# **Queensland Dog Sports**

#### <u>Puppies competing at Lure Coursing Events</u>

The Senior Vice-President commented there was concern with adding puppies to lure coursing events and Dogs Queensland should not be promoting the activity. Discussion followed on the age for dogs participating in such events noting there may be insurance cover issues. Lure Coursing Rule 4.1 stated a dog must be 15 months and over to participate in activities.

Directors requested a reminder of the Lure Coursing Rules and age requirement for dogs participating in fun days, trials or disciplines be published in Paw Prints.

# **Printing of QDS Certificates**

Directors noted the information provided with a notice to be issued in PawPrints to remind clubs of the requirement to print QDS certificates, free of charge, if requested by a member.
