Meeting Grounds Committee July 2024

Directors noted the information with consideration required on fencing between the RATG and lure coursing fields and the container and weight pull shed area. Positive feedback had been provided on the grounds noting the lure coursing people needed to meet on the field to consider the quality. It was noted stagnant water was laying in areas due to the build-up of the ground with the drainage for the area requiring investigation. Any pictures of rocks etc in the area were to be forwarded to the General Manager to address. The luring coursing field was hard and required aeration noting the profiling contractor may have available equipment. It was noted the profiling was scheduled to be moved on 7 September 2024.
