### **Previous Minutes**

### CWLO - Annual Submission from Breeders

Directors noted the information provided and positive steps forward. The number of dog transfers being registered had increased.

Efforts continued to obtain outstanding club annual reports with consideration to be given to sending reminders to the next group of clubs.

### Ekka 2024

Directors noted the information provided, with Ekka 2024 being reasonably successful for Dogs Queensland. Discussion followed on the set up and area of the Dogs Queensland stand, access issues and suggested improvements for Ekka 2025. Ideas included obtaining additional space, playing videos, larger signage, banners and better publicity, Dogs Queensland representatives providing information and engaging more with the public, conducting demonstrations for one hour during lunchtimes and having dogs present at the stand at all times to attract more people.

Additional assistance was required from volunteers noting the area needed to have ready access, for example one or two vehicles allowed at lunchtime in the overflow section and more crew passes. Further work was required on possible options for Ekka 2025 with the General Manager flagging he would also like to attend RNA Canine meetings.

Directors noted the information provided was considered acceptable, with the Senior Vice-President advising she would attend to the matter in the first instance.

A verbal report was provided noting the hands-on event conducted on 24 August 2024. Discussion followed on whether Show Managers' Reports were read and how any incidents were flagged or brought to the office's attention for follow up. General Manager advised issues raised by Show Manager were brought to his attention, with the suggestion the Show Manager program should contain a 'red flag' to highlight any matters. It was noted issues were not being passed onto the CJC with the suggestion Show Manager reports provided to the office staff be copied to the Chair of the CJC.

Directors noted the information provided with the Canine Health Committee Chair speaking to the activities being conducted.

### **Constitution and Rules**

## Minutes C&R meeting 21/08/2024

The minutes of the Constitution and Rules Committee meeting were tabled with Gordon Mayne acknowledging the significant amount of work undertaken by the Committee members.

Discussion followed on each of the proposed Dogs Queensland Rule changes, noting:

- Rule 79.1 and use of 'the precinct' wording and whether defined distances may be more suitable. Consistency
  was required on the application of the precinct rule with agreement the definition wording remain as is and
  if issues arise, the Rule could be revisited.
- Rule 71.9 and issues should the Show Manager not accept the complaint noting the Notice of Intention to
  lodge a complaint should be made on the day as the incident would be fresh in people's mind. Discussion
  followed on who was responsible for incidents during the time before or after shows noting the club/Show
  Manager would be responsible from the time people were allowed to enter the grounds and until everyone
  left.
- Definition for the word 'sign' held over.
- Rule 71.1 (2) and a dog suspended from Exhibition and all activities covered by the Rules for the period from
  the time of the incident until the hearing. It was noted Rule 71.4 allowed remedial training for dogs provided
  the Club agreed to allow the dog on the grounds.
- Rule 71.1 (3) with the suggestion the word 'moral' be removed.
- Appendix 11, noting extreme weather conditions including cyclones were to be considered.
