Previous Minutes

Minutes of Board Meeting – 22 July 2025

CWLO Board Report and DQ Agenda Items for State Admin Conference

The information provided was discussed, noting:

- BOAS testing with the suggestion clarification be sought on the use, operation and training provided for the BOAS testing machine previously purchased by the ANKC noting it could be provided to Dogs Queensland to utilise.
- Status of the Digital Pedigree certificates noting Dogs Queensland and ANKC would accept an electronic document provided by the overseas controlling body.

OTHER AGENDA ITEMS

Universal Registration of Dogs through Dogs Queensland

Directors discussed the information provided noting engagement with and cooperation of local government authorities, Councils and the State Government would be required and legislative changes made if the issue was of interest to the State Government. The technical aspects of setting up a database, data management, administration and costs also needed to be considered. Further planning and investigations were required and preliminary advice obtained on the strategy and processes to consider before progressing further.

Report from Life Member Working Party

Directors discussed the information provided noting the recommendations for the Honorary Life Member award and suggested establishment of a Meritorious Service Award.

The Board further resolved a separate, stand-alone Meritorious Service Award be implemented, with the Life Member Working Party to formalise the process and criteria and make recommendations to the Board on recipients.

Plush Puppy Agreement

Directors discussed the information provided noting Dogs Queensland should not be precluded from approaching other sponsors. Directors agreed further clarification was needed on the agreement terms with added benefits for Dogs Queensland required.

Open Shows Rules and Shows for 2026

Discussion followed on the information provided noting changes may occur as part of the Show Dates review. Correspondence would be issued to those clubs affected by changes noting every effort would be made to schedule Open Shows to maximise entries. The Show Dates Policy previously approved would need to be revised noting flexibility was required with no limitations imposed. A suggestion was provided on the wording for Clause 4.3(b) being 'one or more open shows per calendar year upon approval of the CJC'.

The Board agreed from 2026, not every All Breeds Clubs in Zone 1 would be required to hold Open Shows. The CJC would determine, based upon a variety of factors including location, timing and past entries, which clubs would hold Open Shows in Zone 1. However, all 'Breed Clubs' would still be required to hold at least one Open Show per year.
